

There are only 17 teams, total, competing. Round of 64, round of 32, are just ways of wording what is happening in the k.o. stages. April 29

Dave is right. In fact under this format, the USA1 QuarterFinals (R8) is the first round that will have the expected number of teams competing

No qualifying to enter the 13 team-field which played the round-robin, making it an open competition. Only the teams knocked out of this field (either in the RR or KO stage) plus any of the 4 teams receiving byes who are KO'd, enter the USA2 competition.

Ya think Dwyer was just hustling the Wold and Meltzer teams during the round robin in order to sneak up on them in the K.O.? I don't think that strategy will work.

I have not checked, but they traditionally set the KO by the original seed order and not by the RR results.

Also the last three rounds are not scored until all three are finished. A pair from each team must play all three and are sequestered with no score comparisons allowed. This is primarily so no one gets "help" Qing, but it will also obfuscate the leaderboard at the top.

Al Hollander

there is an adjustment to seeding points based upon RR standing but i don't recall them making a significant impact on pre-rr seed. rules are described in the Conditions of Contest, but i'm typing from fuzzy memory

a couple of caveats:

- * adjustment cannot seed an RR team higher than one that had BYE into KO
- $\mbox{*}$ winner of RR has option to reshuffle within the group of 2 $\mbox{\it April 30}$

It didn't matter yesterday, because Wold declined the reshuffle, but just wondering -- does a reshuffle in a group of 2 mean switching places with the other team, or does it just mean the coin is flipped over again and they might stay the same?

Additional seeding points from the Round Robin are 1st 8 (plus the reshuffle option); 2nd 8; 3rd 4; 4th 2. Sometimes the additional seeding points mattered. I was doing so much last night I don't remember for certain, but I think they did not matter this year.



In the Closed Room, Nickell played in the easy spade partscore. Diamond led the DK. Nickell won the ace in dummy, pulled trump and lost the obvious CAQ and HAQ when both holdings were over the kings.

In the Open Room, Hampson/Greco bid the spade game. I always hope for a holding like KQJ from which to lead... but on this hand, it's deadly! Had Levin led his partner's opening suit, the defense would have collected two hearts and two clubs to defeat the game. However, Levin led the obvious DK. Now Hampson had a chance to play carefully to make his contract.

Geoff won the DA in dummy, discarding a heart from his hand. He played the deuce of diamonds, ruffing with the S5. He cashed the SK and led the SQ to the ace, preserving the S7 as an entry to dummy if he needed it later. He ruffed a diamond with the SJ and played the CT ducked to Weinstein's queen. Weinstein exited with the DT which Hampson ruffed with the ST. The C6 went to the club king and ace. Now all Hampson needed was for clubs to be 3-3. Weinstein, helpless, led his last club. Hampson won the CJ and cashed his C6 pitching a heart from dummy. In the end, he lost only one heart and two clubs for +420 and 7 IMPs to Diamond.

In both rooms, declarer made twelve tricks. The difference was that Katz HAD to make twelve to bring home his contract. Platnick led a diamond to the king and ace. Katz cashed the CA, discarding dummy's other diamond. He played the HK to Diamond's ace and Diamond continued hearts. Katz ran off four more rounds of hearts, Platnick coming down to SQ87 DQ CK; Diamond holding S63 C984.

Katz was at the crossroads. He guessed well. He played a spade to his king and ran the SJ. When that held, he was home free with +980 and 11 IMPs to Nickell.

Following the auction, Oren Kriegel, the VG operator in the Closed Room, made the comment that this hand was a victory for the nebulous Precision 1D opening bid (the bid that had been much discussed of late). Oren suggests that it squelched East's chances of overcalling 1D as was done in the Closed Room above, and allowed Greco, in the Open Room, to play 3NT from North with Weinstein on lead. Weinstein was never going to lead diamonds without the overcall.

Vugraphzfk: A winner for the Precision 1 ♦ opener in the other room-South opened 1 ♦ which preempted the 1 ♦ overcall and put East on lead against 3NT

In point of fact, Weinstein COULD have led diamonds (he didn't... he led a heart) and it would have defeated the contract... while Nickell was in the same situation in 4S.

In both contracts, success all depends on the opening lead.

Diamond led a diamond against 4S and Nickell was able to score his tenth trick with a diamond ruff. Had Diamond led a trump, he could have defeated the game by winning the first diamond with the king and playing a second trump. When Platnick won the third diamond, he could continue spades, removing dummy's last trump and any hope of a diamond ruff, declarer's only chance for a tenth trick with the lie of the heart suit.

In Simson/Harris, the Stansbys played in 3NT from North making four even after Liu found the lead of the DT!!! Lo didn't read it and ducked! (FYI: The Stansbys also play a strong club.) At the other table, Morgan and Barron reached 4S and made four on a diamond lead. No swing.

In Dwyer/Meltzer, Bramley and Hamman bid to 3NT from South! Cohen did not overcall 1C with 1D but he did double 3D mid auction. Cohen led a fourth best diamond and 3NT was defeated a trick. In the other room, Kamil/Becker played 4S and succeeded in taking ten tricks on the lead of a diamond. 10 IMPs to Dyer.

mond ace. Kamil crossed to dummy in spades and played on clubs. After two rounds of clubs he tried to set up spades. Meltzer overruffed the third round of spades and attacked hearts, allowing Kamil to take 11 tricks. The extra trick made no difference.

In the other room Bramley and Hamman bid to 3NT, which had no play on this lie of the cards. Cohler led a small diamond, ducked to Bramley's jack. When Cohen won the third round of clubs, he cashed his diamonds and exited with a spade. The contract was defeated 3 tricks, 300 to E/W and 10 IMPs to Dwyer.


Morgan/Barron played in 3C after a simple forcing-NT auction. The opening lead was the ace of diamonds, Morgan played along the same line as Kamil, and eventually took 10 tricks.

In the other room of Simson/Harris match, the Stansbys bid 3NT on a simple invitational auction. With no information about declarer's heart holding, Liu started with the H5 to the queen, king and ace. Now declarer played on clubs. When Lo won the third round of clubs, he switched to a small spade (the H5, top-of-nothing lead indicated a weak holding). Stansby won the spade return and played a diamond to dummy's king and Lo's ace. Lo cashed his hearts and exited with a spade. Declarer cashed the H9 and conceded, 300 to E/W and 10 IMPs to Harris.

In the Rosenthal/Fleisher match. Pepsi/Rosenberg reached the hopeless 3NT contract and were defeated three tricks after the five of hearts lead. Sontag won the third round of clubs, cashed his two good hearts and exited with a spade. Pepsi cashed the H9 followed by his high spade and tried the spade exit. Berkowitz/ Sontag claimed for down three, 300 to E/W.

In the other room of this match, Willenken/Ginossar reached 5C, after West overcalled 2D and Moss raised to 3D, taking 3NT out of the picture. Willenken received the favorable DA lead and continuation. Willenken led a club to the queen, losing to Moss's king. If Moss held the HK and spades were divided 3-3, the hand could be made. Unfortunately, this was not the position. Moss shifted to a heart and eventually Willenken took 10 tricks, -100 and 5 IMPs to Rosenthal.

The big swing of the day occurred in the second segment of the Dwyer/Meltzer match. 19 IMPs went to the Dwyer team on board 20.

Both tables bid to 7D on similar auctions. West opened 2C and East responded 2D. Both West players rebid 3H showing four hearts and longer diamonds.

On the surface, 7D looks like a pretty good contract. Declarer can discard his third club on the third round of hearts and then trump the third round of clubs and the fourth round of hearts with high trumps.

This line simply requires that hearts break 4-3 and clubs break no worse than 5-2. The possibility of a singleton or doubleton CQ adds an extra chance. The probability of 4-3 hearts is 62% and the probability of 5-2 or 4-3 clubs is 93% for a combined probability of a little less than 58%. The chance of the CQ falling in two rounds increases the chance of success to about 62%.

Mike Kamil followed the old adage of leading a trump against a grand slam. With more frequency than one might expect, one scores a ruff after leading trumps to cut down the opponent's ruffs. Demirev played two rounds of clubs (in case the queen dropped) followed by three rounds of hearts. Kamil ruffed and declarer was held to twelve tricks.

At the other table, Ron Smith held Kamil's cards. Against the seemingly unscientific auction, Smith decided to gamble that either his spade ace was scoring or that it wasn't material and wouldn't cost a trick. Accordingly, Smith led the SA, Lee trumped with the ace (It looks so good to have two aces on the same trick.) and drew two rounds of trumps claiming thirteen tricks and 19 IMPs.

In the other three Open matches, five pairs played in 6D, and one, unexpectedly stopped in the diamond game!
