V. USBF INVITATIONAL 1

Because of the recent Adjudicatory Committee Decision, Dave moved to vacate the USBF Invitational 1 title, and leave it vacant. The Board unanimously approved. The Board then discussed whether the same procedure should be followed if this comes up in the future for an event that is not selecting USBF international teams, and agreed that it should. Aaron moved to vacate any place earned by a team that was either disqualified or withdrew in a future event that doesn't select international teams, and to leave all other placings unchanged. The Board unanimously agreed.

The Board noted that there are already procedures in place to deal with a team that is disqualified or withdraws in a selection event, and those do not need to be changed.

VI. 2021 USBCS

The WBF has tentatively scheduled the 2021 World Championship in Salsomaggiore, Italy for Aug 21-Sep 4, 2021. This includes all events - Bermuda Bowl, Venice Cup, D'Orsi Senior Bowl, Mixed Teams. If the 2021 events are canceled, the WBF has currently said that the World Bridge Games (former Olympiad) will be held in 2022, the World Bridge Team Championships in 2023, and the World Bridge Series ("Rosenblum") in 2024, but this is subject to change.

Without holding an official vote, the USBF Board decided in principle to host USBCs beginning in May 2021, unless the 2021 WCs are canceled or postponed before then. The Board directed Jan to make specific proposals and to consult with the hotel people about what would be possible.

The initial stages of all events would be online. Live play would begin in Schaumburg starting as early as the Round of 8, but perhaps the Round of 4 for some or all events. The women's USA1 Semifinal would overlap the beginning of a semifinal of another event (open or senior's).

Live play would be socially distanced, using individual tablets, with only two screenmates in a room together. Many more safety protocols would be used, and consequences established for disregarding the required safety procedures.

If the WC is canceled before online play starts, the events will be canceled.

If the WC is canceled after online play starts but before face to face play starts, the events will be completely online.

If the WC is canceled after face to face starts, the events would be completed, and the winners would either receive some reward - either the right to be USA1 in 2022 if it is a 2-team year, or guaranteed byes to late stages (Semifinal, or Quarterfinal) in the 2022 USBCs, or some monetary support for any player who

competes in the next Rosenblum, McConnell, Senior or Mixed event in a World Bridge Series. Exactly what will happen is to be discussed at a future meeting.

Suzi is hopeful that a WBF Management Committee meeting will be scheduled soon that will provide more concrete information about the WC plans.

Mark moved to formalize an intent to host 2021 USBCs with preliminary online stages and subsequent live play. Motion carried unanimously.
