To all the Qualifiers: Remember the Captain's meeting today at 10AM Pacific time.

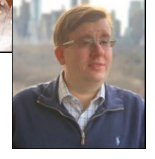
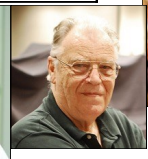
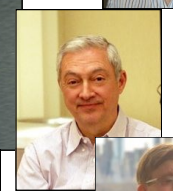
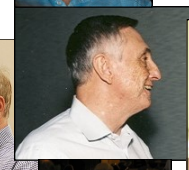
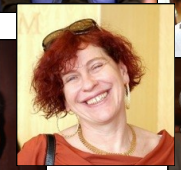
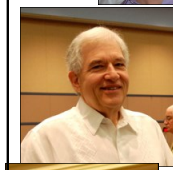
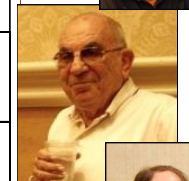
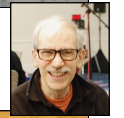

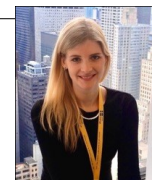
Ethics Statement

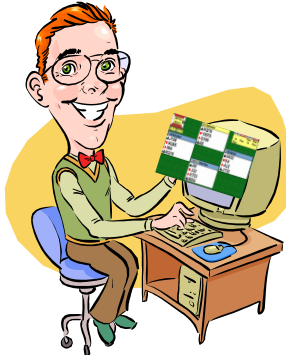

How a hand's bid and played!

To kibitz, go to **kibitzrealbridge.online**, enter your name and click on Log In. That will take you to a screen where you can select the event to kibitz.

After you select Kibitz JLall Online Teams #3, you will be taken to a lobby where you will see a list of tables on the left and a chat box and list of people in the lobby on the right. The table listing shows the team & player names at each table, as well as the board and trick that table is playing (that's in the middle of the table, immediately under the table number). Click on a table to kibitz it.

At the table, you will see a hand diagram, and the bidding and play as it happens. You do not get to hear or see the players yet (that's coming).

There is a chat window on the right of the screen (if your browser window isn't large enough to show it, you can click on the "chat" icon immediately above the UNDO button to open the chat window. For now, anyone can type chat into the chat window.

Some things you can do to get more information:

If there is an asterisk next to a bid, that means it was Alerted or Explained. Click on the bid to see the explanation if there was one.

-- "Rewind" the play using the slider underneath the "table" with hand diagram. just move the vertical handle on the slider to the left to go to earlier tricks.

-- Click on the "Scores" button to the left of the South player's name, you will get a scorecard for the match so far. You can use this to get lots of information:

----Click on a board number to see the hand record and results at all the tables.

----You can also click on a number in a yellow box to get to the hand record from some screens.

----In the hand record screen, click on a result to see the bidding and play at a specific table.

--In the upper left corner:

----Click on the yellow box with 4 little boxes to get the match scores for all the matches (that will be IMPs and for the Round Robin will not include scores from previous rounds).

----Click on the yellow box with 3 bulleted lines to get Cross-IMPs for the pairs (that will be just for this match).

The Scores information is also available in the lobby using the button at the upper right in case you want to check on scores before deciding which table to watch.

TIMING OF DELAY

The Round Robin matches will be delayed until each round is completed.

The first half KO matches will be delayed until each board has been played at all tables, so there may sometimes be a period when nothing new is being shown because one or two tables are slow to play the board. **For the second half of the KO matches, the delay will be until the quarter has been completed.**

That means that the 3rd quarter kibitzing will start at 7:15 EDT.

On Board 1 of RR2 every table played in hearts N/S. The level ranged from game to slam with two tables in between. The contract produced nine to twelve tricks depending on whether it was played from North or South and/or depending on the opening lead and declarer's play at trick one.

The auction to the left is from Jacobs's table in the Jacobs/Onstott match. Koneru's 2C showed two places to play, suggesting that distribution might create a problem. 2D was a transfer to hearts.

Koneru led the CQ. Jacobs had a choice. His could cover the queen or not. He chose to cover and defeated his own game. Compton won the ace; cashed the SA; and returned a club to Koneru's CJ to score a spade ruff. Contract failing one trick.

At the other table, East's 1D showed at least 4.

Beatty, like Koneru, led the CQ. Krekorian ducked!!! Stewart was helpless. He could win his CA on the next round and cash his SA, but he had no transportation to Beatty's hand to score his spade ruff. Contract making! 10 IMPs to Onstott

The two pairs in slam were simply caught speeding and nothing could save them.

Some Suggestions For Dining at Home Between Sessions! Pandemic Pleasures...

STUFFED PEPPERS WITH MINT-YOGURT SAUCE Servings: 6

4 red bell peppers, deseeded. Tops saved
1 cup (190 grams) basmati rice
2 tablespoons (30 ml) olive oil
1 large yellow onion, finely chopped
8 oz. (225 grams) mushrooms, chopped or ground lamb
1/2 cup (75 grams) golden raisins
3 tablespoons (9 grams) chopped dill
3 tablespoons (22 grams) crumbled feta cheese
Salt and black pepper
1-1/2 cups (360 ml) vegetable or chicken stock

To serve:

2 cups (480 ml) marinara sauce

MINT-YOGURT SAUCE

1 cup (240 ml) Greek yogurt
1/2 teaspoon (2 ml) Aleppo pepper flakes (optional)
Finely grated zest of 1/2 lime, plus 1 1/2 teaspoons (7 ml) lime juice
1 teaspoon (5 ml) dried mint
1 tablespoon (15 ml) honey
Salt and pepper to taste

Directions:

Pre-heat the oven to 390 F.

Remove tops of 6 peppers and remove pith and seeds (reserving the tops for later).

Place rice in a saucepan and cover with lightly salted water. Boil for 5 minutes, drain, rinse, and set aside.

Add the olive oil and onions to a frying pan and cook over medium heat until onions are soft and slightly golden. Add the mushrooms (or lamb) and fry for a couple of minutes. Add the raisins, dill and reserved rice to frying pan. Stir in feta cheese, season with salt and pepper to taste.

Evenly divide rice stuffing inside the peppers and top peppers with their lids. Arrange the peppers in a high-sided oven dish, then pour stock over peppers and cover dish tightly with foil. Bake for 40 minutes. Remove the foil and bake for an additional 30 minutes, until the peppers are cooked through and browned on top. Spoon some of the stock on the bottom of the oven dish over the top of the peppers a few times while they are cooking.

Make the Yogurt Sauce by whisking all ingredients in a small bowl and setting aside.

To serve, place about 1/4 cup of the marinara sauce on a plate, top with a cooked pepper and drizzle a little yogurt sauce around the edges.



PERFECT ITALIAN PASTA SALAD

Servings: 8

1 pound fusilli pasta, cooked via box instructions

Salt and pepper

1/2 cup (115 g) extra-virgin olive oil

5 garlic cloves, minced

3 anchovy fillets, rinsed, patted dry and minced

1/2 teaspoon red pepper flakes

1 cup (128 g) pepperoncini, stemmed plus 2 tablespoons (30 ml) brine from jar

2 tablespoons capers(30 ml), rinsed

2 cups baby arugula

20 fresh basil leaves, chopped

1/2 cup (64 g) oil-packed sun-dried tomatoes sliced thin

1/2 cup (64 g) pitted kalamata olives, quartered

4 ounces (110 g) soppressata, cut into 3/8-inch dice

4 ounces (110 g) mortadella, chopped

8 ounces (225 g) fresh mozzarella cheese, cut into 3/8-inch dice and patted dry

Directions:

Heat a sauté pan to medium high. Add oil, garlic, anchovy and red pepper flakes. Cook over medium heat to dissolve anchovies (takes about two minutes).

Divide pepperoncini in half and slice thin rings and set aside. Transfer one half of pepperoncini to food processor. Add capers and pulse 8 to 10 pulses until finely chopped. Use your spatula to scrape down sides of bowl as needed. Add pepperoncini brine and warm oil mixture and process until combined (about 20 seconds).

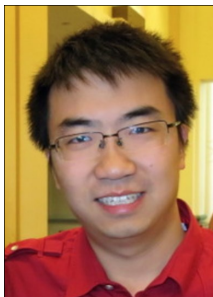
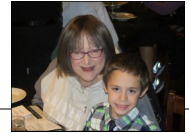
Add dressing to pasta and toss to combine. Add arugula, basil, sun-dried tomatoes, olives, soppressata, mortadella, and mozzarella and reserved half of pepperoncini and toss well. Season with salt and pepper to taste.

STICKY TOFFEE PUDDING

Servings: 6-8

3 tablespoons (45 ml) cold unsalted butter, diced, plus more for buttering pan
18 pitted dates, chopped preferably Medjool
1 cup (240 ml) water
1 teaspoon (5 ml) baking soda
½ cup (107 grams) packed light brown sugar
2 large eggs, at room temperature
1 teaspoon (5 ml) vanilla extract
Grated zest of 1 small orange
1 cup (120 grams) all-purpose flour
1 teaspoon (5 ml) baking powder
½ teaspoon (2 ml) kosher salt

Caramel Sauce:

1 cup (240 ml) heavy cream (divided), at room temperature
¼ cup (53 grams) sugar
1 tablespoon (15 ml) light corn syrup
1 tablespoon (15 ml) pure maple syrup
1 tablespoon (15 ml) unsalted butter
½ teaspoon (2 ml) kosher salt

Directions:

Preheat the oven to 350°F.

Butter an 8-inch square cake pan.

Combine the dates and water in a small saucepan and cook until the dates are softened, about 10 minutes. Mash dates with a fork or potato masher and stir in baking soda and let cool for 15 minutes.

In the bowl of an electric mixer, cream the brown sugar and butter until light and fluffy. Add the eggs, one at a time, mixing well between additions. Add the vanilla and orange zest and mix well. Scrape down the bowl.

Sift the flour and baking powder together and add salt. With the mixer turned off, add the dry ingredients and mix until just combined.

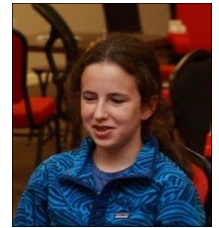
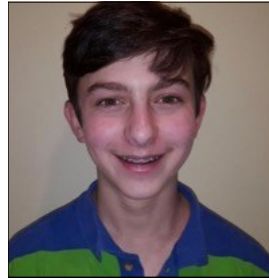
Add the cooled date mixture and mix well until combined. Transfer the batter to the prepared cake pan. Place a piece of paper towel in the center of a larger roasting pan and set the filled pan inside a roasting pan or. Fill the large pan with hot water until it reaches halfway up the sides of the cake pan. Cover the large pan tightly with aluminum foil. This creates a steam method for cooking the cake. Bake the cake for 30 minutes. Remove the pan and let the cake cool for 15 minutes in the water bath, covered.

Whilst cake is baking, make caramel sauce. Place ½ cup of cream, sugar, corn syrup, maple syrup, butter and salt into a medium saucepan and stir well. Bring the mixture to a boil over medium-high heat. Whisk frequently for 15-25 minutes, until the mixture turns a golden chestnut brown color. Add the remaining ½ cup of cream and whisk well to dissolve any lumps. Continue cooking over low heat for about 10 minutes, until deep golden brown. Remove from the heat.

Carefully lift the cake pan from the water bath, use a knife to release the cake from the sides of the pan if necessary. Invert the cake onto a cutting board.

Pour about half of the caramel sauce into the bottom of the pan. Using 2 large spatulas, return the cake to the pan, and pour the remaining sauce over the cake. Let the cake cool completely before serving or refrigerate for up to 3 days.

Cut into slices and serve with any extra caramel sauce.

Every pair who bid Michaels got to the vulnerable 4H game and scored +620.

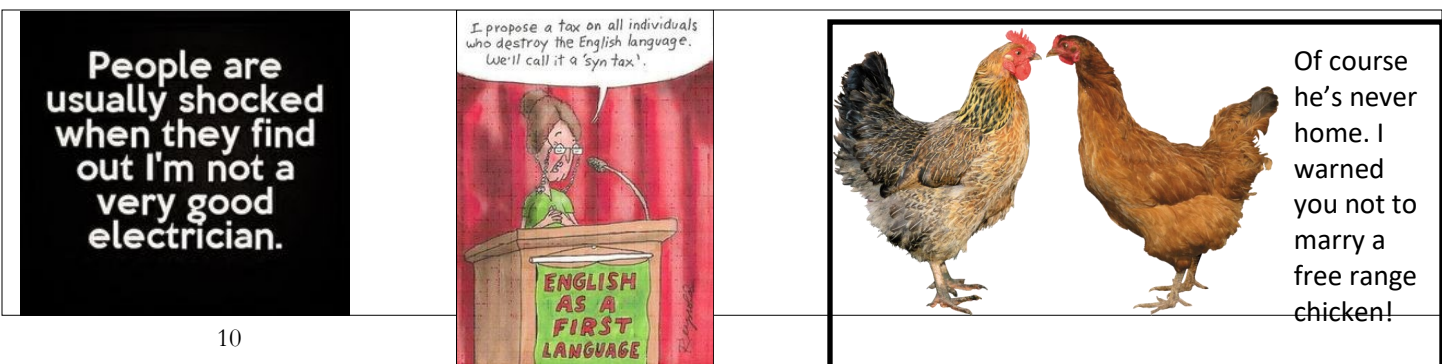
All four tables at the bottom of the traveler who played in 3H making four overcalled 2H. Over 2H, West bid 2S and 3H became ambiguous... was it simply competitive or was it suggesting an invitation to bid game?

When Zhang held the East hand, he passed in first seat so Luba and Lo had an unimpeded auction and bid game easily.

David and Soliman found their way to game after East opened 1S; South overcalled 2H; West raised to 2S and North chose 3NT instead of 3H. South bid 4D and North bid 4H.

Parker and Grossack found 4H after K Rosenberg opened 1C (lead directing?) in third seat.

It would seem that bidding Michaels would be preferable to bidding 2H since you can show partner ten of your cards or only five. It will be easier for him to make a sound judgment with more as opposed to less information.

All ten tables played 4S from the East hand. The auction at seven tables was 1S-1N-4S. At two tables, East self-splintered to show a singleton diamond. (1S-1NT-4D-4S)

At every table where 4S was successful, a trump was the opening lead. The trump picked up partner's AJ7. Frequently, when a player opens four of a major or shows such length, dummy will be void and the only way for declarer to avoid losers in the trump suit is for an opponent to play it for him. Such is the case here.

Weishu Wu led the H6 against 4S after a Gazilli auction. He defeated the game.

Jill Meyers self-splintered diamonds and Charlie Wilkins worked out that a diamond lead would be safe. Accordingly, he led a diamond and the contract was doomed.

Billy Cohen led a heart, the suit where he needed the least from partner to be right. Partner didn't have what he wanted, but declarer had singleton ace so he was fine. Again, 4S went down one!

The less than scientific maxim of "When in doubt, lead trumps" is once again proven to be a myth. Every defender who defeated 4S gained 10 IMPs!

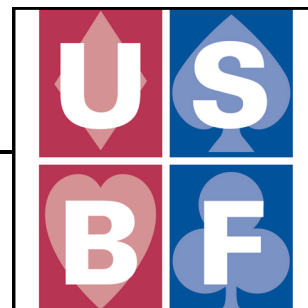

Casen and Krekorian had a particularly good auction. Casen opened 1H and Krekorian responded 2S, explained as artificial-like Jacoby. Lien overcalled 3D and Casen bid 3S, promising a diamond control. Krekorian bid Blackwood and Casen showed 1/4 keycards. That was good enough for Jim who jumped to the heart slam.

There was little to the play. K Rosenberg led a small diamond and Casen won the ace. He played a spade to the ace and finessed the HK, pulled trump and claimed his slam.

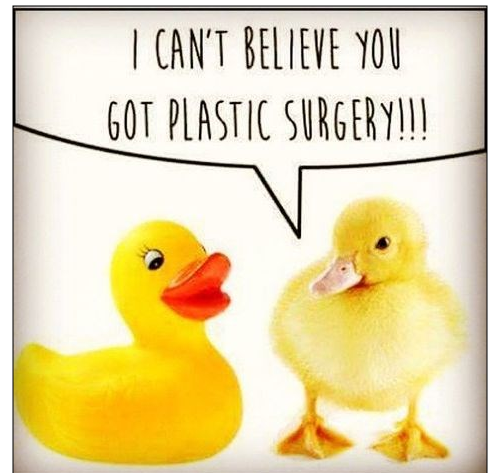
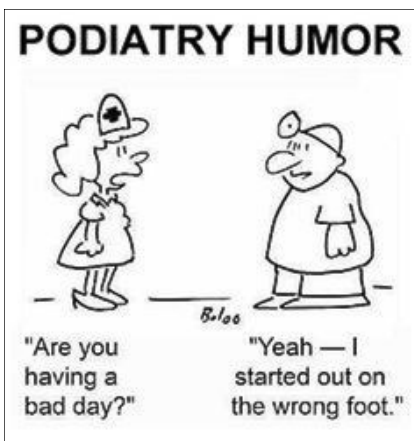

In the other room, Watson opened a modern Flannery (4+ spades and 5+ hearts). While he doesn't hold a maximum by any means, perhaps a 4-6 just plays too well to be opened this way??

One pair only went down in the slam. Dick Bruno led the FOUR of clubs against Luba who rose with the ace and played a second club to establish the CJ for a pitch. Bruno followed with the C3! Kerry Smith won his CK and played a third round of clubs.

Luba, in an abundance of caution, fearing perhaps from the high-low that Bruno started with only two clubs, ruffed with the HQ! This, unfortunately for Luba, established a second trick for HKT now sitting over the jack. This resulted in 17 IMPs to Jacobs when Stewart bid and brought home the slam at the other table.

North declared 1NT at most tables and took six or seven tricks.

In the Dawson/Smith match, accurate defense and a declarer mis-guess resulted in 1NT being set three tricks. Ron Smith led the SQ. When this held the trick, he switched to the HT. This was ducked around to declarer's queen. Since there was no clear entry to dummy's diamond suit, Roger McNay played on spades. He cashed the SA and exited with the S9; Billy Cohen pitched the D2. Smith switched to the C2 and Cohen's CJ held the trick. The C3 was returned, and Smith won the CK and cleared the suit. McNay played a third round of spades. Smith won the spade and played a heart to Cohen's ace. Billy cashed the thirteenth club on which Smith discarded the DK. Cohen led a heart to Smith and Smith cashed the thirteenth heart. Declarer took the DA on the last trick and was defeated by three tricks for -300.

At the other table in the Dawson/Smith match, Smith's teammates, Linda Lewis and Disa found the cold 2D contract and scored +90 producing 9 IMPs for the Smith team.



On the same hand, in the Jacobs/Lo match, Harrison Luba took ten tricks with the same North/South cards.

Dick Bruno led the SK, on which Kerry Smith played the discouraging S5. When this held the trick, Bruno continued with the S8, won by declarer's nine.

Luba cashed the SA and exited with a spade. Dummy discarded the D3 and H5, while Smith discarded the D2 and D4, in that order.

Because they were playing upside down signals, the diamond discards looked encouraging!

Accordingly, Dick played what turned out to be "the not-so-brilliant DK".

Luba won the DA and cashed his last spade, discarding a heart from dummy. Three rounds of diamonds were cashed, and Luba exited dummy with the HJ. This was ducked to Bruno's king.

Bruno returned the CK. Luba won the CA, and took the rest of the tricks, since Smith had been squeezed down to the HA and the Jx of clubs. Declarer scored +180.

At the other table, Stewart/Beatty took seven tricks in 1NT, producing a 3 IMP gain for the Lo team.
