FORMAT OPEN USBC

The face-to-face USA1 stages will be 2-day, 120-board KO matches.

The face-to-face USA2 stages will be a 2-day, 120-board KO R16 in which the 4 losing USA1 Quarterfinalists will play, followed by a 1-day, 60-board KO Quarterfinal, in which the 2 USA1 Quarterfinal losers will play the 2 USA2 Round of 16 winners; a 1-day 60-board KO Semifinal in which the USA2 Quarterfinal winners will play, and a 2-day 120-board Final between the USA1 Final loser and the USA2 Semifinal winner.

Play Requirements: Each player must play 10 matches in RR 1 and at least one segment against each other team in RR 2 to qualify for the KO stages (a player who does not meet the play requirements can be added back to the team as long as the requirements for roster changes are met. Each player must play 50% of the boards in every KO match to be eligible to continue on the team. See General Conditions of Contest Section XII (at USBF.org) about how to count boards and potential waiver of this requirement.

Closed Notes: Players may not consult their notes at any time during play unless they are dummy.

Withdrawal: A player or team may withdraw at any time.

Play in the KO stages will be on LoveBridge tablets, with either 2 or 4 players in a room.

SETTING THE KO BRACKET: The KO bracket will be based on ACBL seeding points, excluding points awarded for online play, plus added seeding points for performance in each stage of the Round Robin.

BaseBall Trivia! Go Sox!

A perfect game in baseball is one in which the same player pitches the entire game without allowing any player of the opposing team to reach first base -- by any means.

At Jack Russell Stadium in Clearwater, Florida, on June 26, 1985, organist Wilbur Snapp played "Three Blind Mice" following a call by umpire Keith O'Connor. The umpire was not amused, and saw to it that Mr. Snapp was ejected from the game.

Babe Ruth hit his first major-league home run on May 6, 1915. He was playing for the Boston Red Sox at the time. 'The Sultan of Swat' went on to smash 714 round-trippers before he retired, from the Boston Braves, in 1935.

Baseball rules were codified in 1846 by Alexander Cartwright of the Knickerbocker Baseball Club.

Baseball's National League was born in 1876. Eight competing baseball teams met in New York City's Grand Central Hotel. The first president of the new league was Morgan Gardner Bulkeley, who later became a US Senator. The eight original cities with teams were: Boston, Chicago, Cincinnati, New York, Philadelphia, St. Louis, Louisville and Hartford. Two of the original teams are now in the American League (Boston and New York) while Louisville and Hartford are now minor-league baseball towns.

Baseball's home plate is 17 inches wide.

KO KIBITZING ON LOVEBRIDGE

You can follow the USBC on the **https://vugraph.lovebridge.com/** website. The stream is delayed; go to the schedule below for starting times for each segment.

Popcorn time! Do you want to listen to commentary? Search for the TV icon! It will send you to the page where you can choose from the available live commentary. If inactive, no one is commenting. **Nail biting!**

Do you want to be deeply involved? Choose the "Match view" at the starting page of your event. Your screen will be divided into four small screens – two of them showing the two tables of the match you choose, the other two having the scoresheet for your match and the current scores of the other matches. In the 2x2 view you can personalize the content in your windows. (Not active on mobiles.)

Think together!

When watching a table, click on a name and choose "Kibitz". Instead of seeing all 4 hands, you will see what the player sees. You can decide what you would do and see whether your chosen player agrees. **More Information:**

Be well informed and tell your friends: while following the play, you can click many items. The image of the sticker with the number of the board (upper right) takes you to the results of the board, in the bottom right corner the arrow takes you the scoresheet, the DDS shows the double dummy analyses, beside that there is a button for the other table of the same match, at the top left corner you can see the bidding with alerts and the explanations (mouse over), the tricks already played, and the double dummy analysis for the available number of tricks with the par score.

Navigation icons:

While surfing here and there in the vugraph, or amongst the archive sessions, there are icons to help you. You can always go back to the main page with the "house" or to the standings with the "scores". If you cannot see the icons, move your mouse, or touch your screen and they pop up immediately. There is also a built-in back button because the back button of your browser will always take you to the starting page. If this is not what you wanted, push next in your browser and you can continue. **Replay**:

After the event you can find every board from every table easily. While replaying the hands, the only surprise can be the way "next board" button works. If you have arrived from a scoresheet, it navigates through the scoresheet. If you have arrived from a screen where the results were shown for a given board then the same buttons move you through the list. Push every button and enjoy!

Mask Rules

Attendees are required to wear a mask that covers their nose and mouth in all public areas in the hotel. That means the hotel lobby, corridors, and elevators, as well as the Hospitality Suite and the Office/Players' Break Room, where masks must be worn at all times. Therefore, there is no eating or drinking in those rooms.

Our attorney has told us that the Cook County Mask Mandate forces us to require masks in the playing rooms. Therefore, we have adopted the following policy about that:

Masks are required in playing rooms. If you are observed not wearing a mask in a playing room, there will be a 2 IMP penalty for the first offense in a segment, a 4 IMP penalty for the second offense, an 8 IMP penalty for the third offense, and a 16 IMP penalty for the fourth and subsequent offenses; however, if you and your opponent agree to something other than both wearing masks, any IMP penalties for not wearing a mask will apply to both of you equally and there will be no other penalties. You may remove your mask briefly to eat or drink. **However, if you call for a director (for any reason), and you are not wearing a mask properly when the director enters the room, the penalty will apply to your team for your next match in the event.** There is no eating or drinking in the playing room when the Director present.

In addition, anyone who is penalized more than twice (over the course of the entire event) in situations where his/her opponent was wearing a mask while s/he wasn't, or where the director was called, may be subject to additional conduct penalties.

You should bring masks to the tournament with you; we will not be supplying masks.

Covid Waiver

We are going to ask each player in these events to sign a COVID-19 Waiver of Claims. It is being sent to you by email and you may sign it electronically and return it to Jan (<u>marteljan@gmal.com</u>) or you can sign a printed waiver at the site. Waivers will be available to sign in room 1321 starting Oct. 5th at 9:00 am. **Everyone is required to sign the form before the start of play!**

Hospitality Information ... the Suite and more ...

Because of Covid, we won't be able to provide the full, wonderful hospitality we have in the past, but we will do what we can.

Hosts Evvie Gilbert and Maya Alela for the Open and Women's and Julie Arbit and Christian Jolly for the Mixed and Seniors will be in our usual hospitality suite (Room 2321). They will provide grab and go breakfast and lunch each day, starting on Tuesday, Oct. 5th.

Breakfast: From 8-10 am. There will be individually packaged cereal, fruit, hard boiled eggs, bagels, and some hot options. Also individual butter, jam, peanut butter, and cream cheese, as well as condiment packages. They will be making coffee and will have individual packages of sugar, sweetener, and dairy & non-dairy creamers. For those of you who prefer Keurig coffee, that will also be available in the hospitality suite. We are limiting access to 6 players at any one time, so we ask that you come to the suite, pick up a large to go container and put the smaller packages in that to take with you as quickly as you can, and then go someplace else to eat. **Masks that cover your nose & mouth must be always worn in the Hospitality Suite.** There will be a hand sanitizer station near the door and we encourage you to sanitize your hands before choosing what to take.

Lunch: From 2-4 pm (the first half of play each day ends at 2:35; we encourage those of you who are sitting out the 2nd quarter to go early). There will be a main dish (sandwiches, chicken, maind dish salads, pizza) as well as individually packaged tuna salad, green salad, cheese, fruit, and berries. Also all the individual packages of add-ons we have for breakfast. Water and soft drinks will be available in refrigerators.

Let us know what you want: If there is a menu for a future day's lunch hanging on the wall outside the Hospitality Suite, please mark what you want, so we have a better idea of what to order.

Playing Rooms & Player's Break Room

We will have bottled water in the playing rooms and if there is a refrigerator in a playing room, we'll stock it with soft drinks.

We will also have bottled water in the Player's Break Room (1321), as well as soft drinks, Nespresso, some packaged snacks, and some fruit.

Masks that cover your nose & mouth must be always worn in the Player's Break Room, so you may not eat and drink in the room.



Paints Unlimited, the town's house painting service, has already been very busy this year. Already they've finished five houses, each completed with outbuildings such as sheds and garages. But some of his employees waited with interest when a new call came in, to see if the trend continued throughout the year. Determine the original color of each house, what street each house was on, the new color each house was painted, and the last name of the owners of each house.

- 1. The blue house was painted yellow. The Smith family didn't live on Prescott Street.
- 2. The original brown house and the house that was

painted brown were, in no particular order, the house on Prescott Street and the house that the Grant family owned.

- The Wilson family didn't live on a street that starts with an "S". The Parker's house was originally green. The house on Summer Street wasn't painted green.
- South Street was the address for the newly painted white house. The house on Prescott Street, which wasn't a blue house, didn't belong to the Jones family.
- 5. The Wilson's house wasn't blue, before or after painting. The original yellow house was not on Forest Street.
- 6. The Smith family home was originally white. The Parker family home was on Wood Street. The home of the Jones family was not on South Street.


There is to be a free BBO Tournament in memory of Miguel Reygadas on 16 October. So do save the date and look for registration details on BBO

Bramley/Woolsey had a well-defined Strong Club Relay auction to reach 6D on Board 31 from the seventh segment of the Open USA2 Finals.

Woolsey opened with 1C (strong and artificial). Bramley's 1S response was game forcing and showed four or more hearts without four spades. 1NT was a relay and Bramley's 2H response showed four hearts and five or more diamonds. 2S was a relay and Bramley bid 3C to show 2-4-5-2 distribution. Woolsey's 3D bid asked for controls and Bramley showed three controls

(A=2 controls, K=1 control). Woolsey bid 4C to ask what controls Bramley held. Bramley's 4H bid showed either the DA or DK and denied the HA or HK.

Woolsey knew that Bramley's three controls were the SA and the DK. There were no black suit losers and only one heart loser. Slam seemingly depended on nothing worse than a 2-2 trump division. In the actual case, Bramley's DJ improved the odds of not losing a trump.

Spector led the SQ, Woolsey won the SA and led a heart to West's ace. Spector returned a heart, which Woolsey trumped in his hand. Woolsey led a diamond to the ace and a diamond to the king, dropping the DQ. Woolsey cashed the CAK and, when the CQJ fell, he was able to claim twelve tricks, scoring +1370.

At the other table of the USA2 final, John Hurd opened 1NT with South hand. Bathurst bid Stayman. When Hurd denied a four card major, Bathurst placed the contract in 3NT. Hurd took nine tricks for +600.

13 IMPs well earned for Bramley ... and one of the best auction of the tournament so far!

In the Palmer matches, the results were somewhat different.

In the Baker/Wittes USA1 Final, Quinn/Wittes had a natural auction to reach the nine trick notrump game scoring +600.


At the other table Disa/Molson stopped in 2C!! when Disa opened 1C and rebid 2C over Molson's 1H response.




In the Palmer USA1 Final, Quinn/Wittes picked up a slam swing on Board 50. The bidding was basically natural, with2D being fourth -suit-forcing to game. 4NT was RKC in spades. Quinn chose to show her four card spade suit before rebidding her six card diamond suit.

When Wittes showed strong spade support by bidding fourth-suit-forcing and jumping to 4S, Quinn checked for keycards and drove to slam. Disa led the H3. Quinn won the HA and drew trumps in three rounds, ending in dummy. Quinn played the DJ to the DA and took the ruffing finesse for the DK. Disa covered the fourth round of diamonds. Quinn ruffed and played a club to the king, claiming twelve tricks for a score of +1430.

At the other table Meyers/Sanborn stopped in 4S when Meyers jumped directly to 4S over 1S, rather than going through fourthsuit. Sanborn took all thirteen tricks when the CA was ducked twice for +710.

Questions asked by Players in the Open and the Mixed... FAQ's from Jan Martel

Chat

• *My physical keyboard isn't working!* Make sure to click/put focus into the chat box before attempting to type in the box. (The blinking cursor makes it seem as though focus is there, but it may not be.) This seems to only occur with an external keyboard, not the virtual keyboard.

• What does that number on the left side mean? You have unread chat message(s). Click on left gray arrow to open chat and right gray arrow to close the chat. (If you actually type and send a message, the chat will close automatically. Reopen with left gray arrow.)

• Why can't I chat to my partner? For security reasons, chat to partner is not available while cards for a new hand are on display. Since there is no "between round down time," there is no real partner chat.

Bidding

• **The system won't let me pass!** If you have the level (1 through 7) highlighted, you will be unable to pass/double/redouble. Click on the highlighted numeral to remove the highlight, then make the desired call.

• **My explanation keeps disappearing!** If you alert your bid as you make it but go back later to explain, there is a bug in the system where subsequent table actions will erase any text that you have typed into the explanation box. If you include your explanation with your call or when it is your turn to act, then this will not occur. (We have reported this issue to LoveBridge.)

• Where is the undo button? While there is no undo button, every call made is followed by a brief cancellation time period. A cancel button will appear immediately below the call selected in the top center portion of the screen. If you cancel within the time period, your bidding panel will reappear for you to select the intended call. If you do not cancel within the time period, summon a director (hit red TD whistle) to request an undo.

Play

1. Why can't I click on a card? The default setting for LoveBridge is neither a tap/click nor a double tap/click. The default setting is a drag-and-drop motion where the player pulls a card to the gray box in the center of the screen and releases to play the card. If the "pulled" card is not the intended one, the player can drag it back to the hand and select another card. We recommend this setting while players are getting accustomed to the system. Players may change this setting to double tap/click if desired, but we strongly discourage single tap/click settings.

2. Whose turn is it? In the bidding or play of the hand, the player's direction letter (N S E W) will be white inside of the circle when it is the player's turn. This is a very subtle change from the normal pale blue letter.

3. *How do I claim?* During the play, you may click the larger red box <u>below</u> the TD whistle to claim. If the claim button is grayed out (not available), you either already contributed a card to the current trick or you are dummy.


How do I see the bidding once play has started? A player is not entitled to the entire auction once they have played to trick 1. If you have not yet played to trick one, the auction will be in the lower left corner. Click on it to enlarge to the center area. Click the double gray arrows in the bottom right of the center area to send it back to the corner. Similarly, this is how a player may see the cards from the previous trick (prior to playing to current trick).

At favorable, John Kranyak, North, chose to open 4C on his seven card suit to 100 honors.

This bid made it impossible for his opponents to bid and play 3NT. Bramley/Woolsey found the only reasonable alternative: 5D, but alas, they had to lose one club, one club ruff, the offside DK and the offside SK.

Contract failing two tricks.

In the other room where Mike Becker opened 3C, Bathurst overcalled 3NT and played it there.

Kamil led the HQ. Bathurst won in hand with the king. Bathurstplayed a diamond to the ten, a diamond to the ace (Becker


discarding the CQ), and the DQ to Kamil's king. Kamil played the D9, won in hand by Bathurst with the jack. Bathurst cashed two high diamonds and led the HT, covered by the jack to the ace. The H8 was led off dummy, Kamil winning the nine. The S7 went to the queen and the SA was cashed, Bathurst conceding the last two tricks to the CAJ with Becker.

Kamil was enplayed when he won the H9. He either had to lead a spade into declarer's AQ or lead a club to his partner's ace, establishing declarer's CK.

Either way, Bathurst had nine tricks and the vulnerable game.



On the last board of the Palmer USA2 Semifinal, Disa/Molson could have sold out to 3H by Wittes. This contract has five losers: three spades and two hearts. However, Disa, who opened 1D with 18 HCP and passed on the next round, decided to reopen with a double. Molson bid 4D to end the auction.

E/W took two trump tricks and three club tricks to defeat the contract two tricks and score N/S +100.



At the other table Amber Lin opened 1D and Emma Kolesnik preempted 3D over Meyers's 1H overcall. Sanborn jumped to 4H. Lin, who had a very good defensive hand, doubled. Kolesnik led a diamond. Meyers won the DA in dummy, led a diamond to the ace and trumped her last diamond. A heart was led from dummy. Lin played the HA followed by three rounds of spades. Lin exited with a club and Kolesnik later collected the HJ to defeat the contract two tricks and score E/W + 500.

12 IMPs to Wittes, who bested the favored Baker team by 39 IMPs to become USA1 in the upcoming WBF competition.
