Welcome to Schaumburg, Illinois for the 2022 United States Bridge Championships. We will be selecting USA1 for the 2023 Bermuda Bowl, from October 24-November 4, 2023, in Marrakech, Morocco.

There are 16 entered so the entire event will be held face-to-face. **Proof of vaccination is required.** 

Based on your enthusiastic survey responses to our last event, we will again be using the LoveBridge tablets with the LoveBridge software with only two occupants per room during play.

Format: We will play 2-day, 120-board KO matches.

**Play Requirements:** Each player must play 50% of the boards in each KO match in order to be eligible to continue on the team. See General Conditions of Contest Section XII for how to count boards and potential waiver of this requirement.

**Closed Notes**: Players may not consult their notes at any time during play, unless they are dummy.

Withdrawal: A player or team may withdraw at any time.

A player who has tested positive for Covid-19 will be allowed to continue to play, but will be required to play in a separate room. Both the Covid-positive player and his or her screenmate will be recorded on video during play.

While the USBF Board of Directors and the tournament organizers do their best to make this event the fairest Competition year after year, only YOU, the players, can uphold the high level of ethics, camaraderie and sportsmanship for which United States bridge is known worldwide.

I will do my part to uphold these standards and I ask that each of you keep this in mind throughout the event.

Let the games begin!

# **Hospitality Suite...**



Because of Covid, we won't be able to provide the full hospitality we have in the past, but we will do what we can.

Hosts **Maya Alela** and **Marie-France Benoit** will be in our hospitality suite (Room 2321). They will provide grab and go breakfast and lunch each day, except that on Monday and Tuesday, lunch will be a buffet in the hotel restaurant.

**Breakfast**: From 8-10 am. There will be individually packaged cereal, fruit, hard boiled eggs, bagels, and some hot options. Also individual butter, jam, peanut butter, and cream cheese, as well as condiment packages. Maya & Marie-France will be making coffee and will have individual packages of sugar, sweetener, and dairy & non-dairy creamers. For those of you who prefer Keurig coffee, that will also be available in the hospitality suite. We are limiting access to 6 players at any one time, so we ask that you come to the suite, pick up a large to go container and put the smaller packages in that to take with you as quickly as you can, and then go someplace else to eat. Masks that cover your nose & mouth must be worn in the Hospitality Suite at all times. There will be a hand sanitizer station near the door and we encourage you to sanitize your hands before choosing what to take.

**Lunch**: Monday, from 2:30-5:00 and Tuesday from 2:00-4:30 there will be a buffet lunch in the hotel restaurant. You will need to show a convention card or SSF to prove you're with the bridge tournament. Please tell the hotel staff if you see someone who isn't one of us, since we are paying for each lunch. From Wednesday on, lunch will be available in the hospitality suite from 2-4 pm (the first half of play each day ends at 2:35; we encourage those of you who are sitting out the 2nd quarter to go early). There will be a main dish (sandwiches, chicken, main dish salads, pizza) as well as tuna salad, green salad, cheese, fruit, and berries... Also all the individual packages of add-ons we have for breakfast. Water and soft drinks will be available in refrigerators.

**Let us know what you want**: If there is a menu for a future day's lunch hanging on the wall outside the Hospitality Suite, please mark what you want, so we have a better idea of what to order.

#### Playing Rooms & Player's Break Room

We will have bottled water in the playing rooms and if there is a refrigerator in a playing room we'll stock it with soft drinks.

We wil also have bottled water in the Player's Break Room (1321), as well as soft drinks, nespresso, some packaged snacks, and some fruit.

AGAIN: Masks that cover your nose & mouth must be worn in the Player's Break Room at all times, so you may not eat and drink in the room.

If you want to listen to commentary, search for the TV icon to choose from the available live commentary. If it doesn't respond, no one is commenting.

#### Nail biting!

You can choose the "Match view" at the starting page of your event and your screen will split into four small screens – two showing the two tables of the match you choose, the other two having the scoresheet for your match and the current scores of the other matches. In the 2x2 view you can also personalize the content in your windows. (The 2x2 view is not available on mobile devices.)

#### Think together!

When watching a table, click on a name and choose "Kibitz". Instead of seeing all 4 hands, you will see what the player sees, and you can decide what you would do and see whether your player agrees.

#### More Information:

The image of the sticker with the number of the board (upper right) takes you to the results of the board, in the bottom right corner the arrow takes you to the scoresheet, the DDS shows the double dummy analyses, beside that there is a button for the other table of the same match, at the top left corner you can see the bidding with alerts and the explanations (mouse over), the tricks already played, and the double dummy analysis for the available number of tricks with the par score.

#### Navigation icons:

While surfing here and there in the vugraph, or amongst the archive sessions, there are icons to help you. You can always go back to the main page with the "house" or to the standings with the "scores". If you cannot see the icons, move your mouse, or touch your screen and they pop up immediately. There is also a built-in back button because the back button of your browser will always take you to the starting page. If this is not what you wanted, push next in your browser and you can continue. Replay:

After the event you can find every board from every table easily. While replaying the hands, the only surprise can be the way "next board" button works. If you have arrived from a scoresheet, it navigates through the scoresheet. If you have arrived from a screen where the results were shown for a given board then the same buttons move you through the list. Push every button and enjoy!

# Hard Logic Puzzle...

This conundrum, a variation on a lying/truth problem, has famously been called the hardest logic puzzle ever. You meet three gods on a mountain top. One always tells the truth, one always lies, and one tells the truth or lies randomly. We can call them Truth, False and Random. They understand English but answer in their own language, with ja or da for yes and no—but you don't know which is which. You can ask three questions to any of the gods (and you can ask the same god more than one question), and they will answer with ja or da. What three questions do you ask to figure out who's who?

**Answer:** Before getting to the answer, let's think of a hypothetical question you know the answer to, such as "Does two plus two equal four?" Then, phrase it so you're asking it as an embedded question: "If I asked you if two plus two equals four, would you answer ja?" If ja means yes, Truth would answer ja, but so would False (he always lies, so he'd say ja even though he really would answer da). If ja means no, they both would still answer ja—in this case, False would answer the embedded question with ja, but saying da to the overall question would be telling the truth, so he says ja. (Random's answer would be meaningless because we don't know whether he lies or tells the truth.)

But what if you said, "If I asked you if two plus two equals five, would you answer ja?" If ja means yes, Truth would answer da, as would False; if ja means no, they'd also both answer da. So, you know that if the embedded question is correct, Truth and False always answer with the same word you use; if the embedded question is incorrect, they always answer with the opposite word. You also know they always answer with the same word as each other.

With this reasoning, ask the god in the middle your first question: "If I asked you whether the god on my left is Random, would you answer ja?" If the god answers ja and you're talking to either Truth or False, following the above logic you know the embedded question is correct, and the god to the left is Random. It's also possible that you're speaking to Random; but you know no matter who you're talking to, the god on the right is *not* Random. If the answer is da, the opposite is the case, and you know the god on the *left* isn't Random. Next, you can ask the god you definitely know isn't Random a question using the same structure: "If I were to ask you if you are Truth, would you say ja?" If they answer ja, you know you're talking to Truth; if they answer da you know you're talking with False. Then once you've identified that god as True or False, you can ask the same god a final question to identify Random: "If I asked you if the god in the middle is Random, would you say ja?" By process of elimination, you can then identify the last god.

**Logic Puzzle:** A bad guy is playing Russian roulette with a six-shooter revolver. He puts in one bullet, spins the chambers and fires at you, but no bullet comes out. He gives you the choice of whether or not he should spin the chambers again before firing a second time. Should he spin again?

**Answer:** Yes. Before he spins, there's a one in six chance of a bullet being fired. After he spins, one of those chances has been taken away, leaving a one in five chance and making it more likely a bullet will be fired. Best to spin again.

# Less Tough Durrhae

**Logic Puzzle:** Same situation, but two bullets are put in consecutive chambers. Should you tell the bad guy to spin the chambers again?

**Answer:** No. With two bullets, you have two chances in six (or one in three) to get hit with a bullet before he fires the first time. Because we know the previous round was one of four empty chambers, that leaves four positions the gun could now be in, with only one followed by a bullet; therefore leaving you with a one in four chance the second round will fire. Since one in four is better odds than one in three, he shouldn't spin again.

# **Meet the Players and the Captains!**



As a MIT alumni Bronia Jenkins, began her career as an FX Options trader at O'Connor and Associates. She remained at OCA through mergers with SBC and UBS working in Basel and London concluding her engagement at UBS as co-head of FX Options. She co-founded Volbroker, the world's leading electronic FX options platform through the merger with ICAP. She joined Bank of America as Head of FX Options, finishing there as Head of FX-North America before taking a "sabbatical" to raise her children. Bronia rejoined the workforce as a high school mathematics teacher and is looking forward to joining the two worlds of Education and Capital Markets.

At this USBC, Bronia is NPC of her significant other's team including Billy Cohen, Sherry Winestock, Josh Dunn, Ron Smith and Gary Cohler. Years ago, Bronia chose to play more physical sports like tennis and her bridge playing time

suffered. Then, out of the blue, she severed her Achilles tendon while playing a tennis match at Quail Valley in Florida, and returned to bridge through the route of "online".

"I've been playing a long time, and I play at a very high level, but I don't play enough," Jenkins said. "I'd like to play more. To be super competitive, you need to play more. Bridge is a game you can continually get better at. As much as I've played over the years, I still constantly make mistakes," she added. "I can always look back and see something I could've done differently. There's so much that goes into it: strategy, tactics, probabilities, statistics, table presence . . . That's why I enjoy the game so much." Jenkins was born in France and grew up in Montreal and San Diego. She's always enjoyed playing cards and board games.

"In chess, everything is out there on the board and the better players are going to win every time," Jenkins said. "In poker, there's some skill involved, but there's a lot of luck, too. You can be the better player, but, sometimes, the cards just don't come your way.

"Bridge is in the middle," she added. "Anyone can beat anyone on any given hand, but, over the long run, the better player is usually going to win."

Over the years, when she wasn't on hiatus, she has played across America in regional and national tournaments, earning a reputation as a serious competitor.

At one time, Jenkins' longtime friend and former bridge partner, Sheri Winestock of Las Vegas (via Canada), called and asked if she'd be interested in playing in the U.S. Bridge Championships.

"We started off talking about playing bridge again, just for fun, then she brought up the team trials," Jenkins said, referring to the U.S. championships by their generic name. "When we decided to do it, it was just about playing some bridge and having a good time."

Then the No. 1 seeded team lost during the round-robin phase, creating an opening for Jenkins' team to play its way to the world championships.

"We got lucky," she said of her first trials experience and qualifying for her first trip to the world championships. Men's and women's teams from eight zones competed in the two-week tournament.

Jenkins' team played in the Venice Cup representing the United States. Her experience with the team will suit her well as captain of her team here in Schaumburg.

The Village of Schaumburg was incorporated on March 7, 1956, but the heritage of Schaumburg dates back to the much earlier times when the first inhabitants of the area were members of the Sauk, Fox, Pottawatomie, and Kickapoo Indian tribes. By the mid-nineteenth century, settlers first began to arrive from Germany and the eastern United States. Legend has it that the earliest settler was Trumball Kent from Oswego, New York. Kent, a "Yankee," as settlers from New England were called in the west, founded a settlement in 1835 not far from what is now called Olde Schaumburg Centre, formerly known as Sarah's Grove. The first recorded settler of Schaumburg Township was German born Johann Sunderlage. According to legend, Sunderlage was a member of a survey team that divided Cook County into townships around 1833. He liked the area so much that, upon completion of the project, he brought his family from Germany and settled in the area around 1836.

Sunderlage and his family occupied their land in the Township until the federal land sale of 1842 allowed them to purchase the property and obtain the deed. Sunderlage and Kent represented the predominant groups that settled Schaumburg Township in its early days. In 1840, 56 percent of the Township households originated from the eastern United States, while 28 percent were German-born. By the 1850s, the population mix had settled to 28 percent "Yankee" and 48 percent German.

By 1870, Schaumburg Township had become completely German. Land records show that all the property in the Township was owned by German immigrants or their descendants. This pattern emerged as many Yankee settlers continued to travel west for the promise of newly opened lands on the Great Plains. The land they occupied in Schaumburg was then purchased by German-born immigrants.

Schaumburg Township remained almost exclusively under German ownership until the Great Depression of the 1930s. The Depression caused the foreclosure on some German-owned farms which were then purchased by non-German individuals and companies. Nonetheless, German heritage remained important in the area. German was the first language of the majority of households until the 1950s. St. Peter Lutheran Church, the community's oldest church which was constructed in 1847, held services in German as late as 1970. Schaumburg Township was originally known as Sarah's Grove. This name was derived from a grove of woods that ran through the northwest portion of the Township, which was named for three young women whose families lived adjacent to the grove: Sarah McChesney, Sarah Frisbe, and Sarah Smith. However, the name was never made official. Until 1851, the area's official name was Township 41. At the 1850 Township meeting, residents discussed two names for the Township; Lutherville and Lutherburg. In the middle of the discussion Frederick Nerge, a prominent German landowner, put his fist down on the table and called out, "Schaumburg ichall et heiten!" (It will be called Schaumburg!). With this statement, a consensus was reached on the Township's official name.

This chosen name derived from Schaumburg-Lippe, the part of Germany where many of the Township's residents originated. The majority of German settlers were from the Hesse-Kassel or Hanover districts, but apparently those from the Schaumburg area had more influence in the community's affairs.

Schaumburg Township prospered during its early days. The area's main occupation was farming, with potato growing, dairy products and raising cattle as main sources of income. The land was a very large meadow surrounded by extensive wilderness. Wildlife such as geese, ducks, quail, prairie chickens, rabbits, and deer were very abundant.

In 1858, a small market area emerged at what is now the intersection of Schaumburg and Roselle Roads. Schaumburg Centre functioned as the central service district for the surrounding agricultural producers. It included two general stores, four cheese factories, a cobbler, a tailor, a wagon maker, and a blacksmith.

Most of the early growth in the Northeast region of Illinois occurred along the Fox River Valley and the major rail lines. Since neither of these transportation networks served Schaumburg Township, the Township remained rather isolated. Few roads existed, and several were often impassable. To reach the market, Schaumburg farmers had to travel 27 miles by oxen or horses to Chicago, which only had about 35,000 inhabitants at that time.


In 1900, during a period of German nationalism, a 50 year anniversary brochure reported the following account: "Schaumburg has, as an important English daily newspaper said: 'The reputation of being the model community of Cook County. Also, the town of Schaumburg is an example of a community for all other towns in Cook County and probably in other counties, too. Schaumburg is prompt in the payment of its taxes; it supports churches and schools; it has also the best roads in the land and - Schaumburg has never had a jail.' Finally, it is not just for the settlers only, but also for foreigners."

This isolation was broken, however, as the automobile became the primary means of transportation. Two projects, the expansion of O'Hare Field into a major international airport in 1955 and the construction of the Northwest Tollway in 1956, put Schaumburg in an ideal location for suburban growth. In response to development pressures, the area encompassing what was known as Schaumburg Centre, was incorporated in 1956. At the time of incorporation, the Village consisted of two square miles and a population of 130 residents.


Incorporation enabled the village to control its growth and development. Early village leaders are credited with the foresight and planning that has made later economic growth possible. The original comprehensive plan adopted by the Village Board in 1961, reserved large tracts of land for industrial, commercial, and office development. Growth in these sectors has made the village a major area employer and the State's second largest retail center, Woodfield Mall.

#### Fun Fact About Schaumburg:

Schaumburg might not be the most popular area in Illinois but it definitely attracted some productions to film within the area over the years. Some of the movies that shot scenes in places around Schaumburg were Bad Teacher, Blood and Wine, and The Founder.

## **Everything You Need to Know About LoveBridge and May Have Forgotten!**

#### MAY 2022 FAQ FOR LOVEBRIDGE

#### Chat

- My physical keyboard isn't working! Make sure to click/put focus into the chat box before attempting to type in the box. (The blinking cursor makes it seem as though focus is there, but it may not be.) This seems to only occur with an external keyboard, not the virtual keyboard.
- What does that number in the upper left mean? You have unread chat message(s) and the strip at the left will be a sky blue until you read them (the number indicates how many unread messages are there). Click on the number/strip on the left to open/view. Click the X in top right corner to close. When all messages are read, the strip is grey.
- Why can't I chat to my partner? For security reasons, chat to partner is not available while cards for a new hand are on display. Since there is no "between round down time," there is no real partner chat.

#### Bidding

- **The system won't let me pass!** If you have the level (1 through 7) highlighted, you will be unable to pass/double/redouble. If you try do so, the reset button will start flashing. Click the reset button to refresh.
- Where is the undo button? While there is no undo button, every call made is followed by a brief cancellation time period. A cancel button will appear immediately below the call selected in the top center portion of the screen. If you cancel within the time period, your bidding panel will reappear for you to select the intended call. If you do not cancel within the time period, summon a director (hit red TD whistle) to request an undo (second option).

#### Play

- 1. Why can't I click on a card? The default setting for LoveBridge is neither a tap/click nor a double tap/click. The default setting is a drag-and-drop motion where the player pulls a card to the gray box in the center of the screen and releases to play the card. If the "pulled" card is not the intended one, the player can drag it back to the hand and select another card. We recommend this setting while players are getting accustomed to the system. Players may change this setting to double tap/click if desired, but we strongly discourage single tap/click settings.
- 2. Whose turn is it? In the bidding or play of the hand, the player's direction letter (N S E W) will be a white letter inside of the circle with a pale blue outer circle when it is the player's turn. The auction is always displayed so that you are on the very right and your hand is at the bottom.
- **3.** *How do I claim?* During the play, you may click the larger blue box <u>below</u> the TD whistle to claim. If the claim button is grayed out (not available), you either already contributed a card to the current trick or you are dummy. (Note that you may not claim mid-trick. You may only claim between tricks.)
- **4.** How do I see the bidding once play has started? Per the Laws of Duplicate Bridge, a player is not entitled to the entire auction once they have played to trick 1. If you have not yet played to trick one, the auction will be in the lower left corner. Click on it to enlarge to the center area. Click the double gray arrows in the bottom right of the center area to send it back to the corner. Similarly, this is how a player may see the cards from the previous trick (prior to playing to current trick).


In addition, we will have some tablets set up in the bar area of the hotel lobby on Sunday afternoon & evening for you to practice on.

When you start to play on Monday, just call the director for any and all tablet-related issues.

\*\*\*One of the changes LoveBridge made for us for this year is a sub-menu that appears when you press the "Director" button so you can specify what the call is for:




If your call is for one of the top 2 reasons, play will stop at your table (including your partner's room). If your call is for one of the other reasons, someone (not necessarily a director) will come to your room to deal with the issue and play will continue at your table and your partner's table. Please select "Tech issue" for any tablet problems. Non-bridge is for an escort if you want to leave the room to smoke, a request for coffee, and things like that.

The CC button will open one PDF with the opponents' SSF and ACBL Convention card, as well as the ACBL Multi defense if your opponents are playing Multi The SSF and Convention card are as of the closing date for System submission. If you make any changes to your convention card after today, they will only be displayed if you tell me that you have done so, in which case I will update what is loaded into LoveBridge.

#### Explanations

Remember that even though you and your screenmate are in the same room so you can explain things verbally, you are still required to alert and/or explain your bids in writing on the tablet, so the opponent on the other side of the screen gets the information and we have a record of your alerts & explanations.

To make an explanation, you first need to access the keyboard. You do that when it is your turn to bid by clicking in the explanation box, which will open the keyboard for you. After you have made a bid, you can add an explanation by clicking on the envelope icon below the explanation box and then typing in the box.

To get to the Android keyboard, click on the picture of the keyboard at the left of the bridge keyboard. To get to other bridge keyboards, click on one of the other buttons to the left and right of the keyboard.

After you make a bid, you will have 3 seconds to cancel it. If you want to undo after the 3 seconds, you need to call the director and request an undo, which will only be granted in unusual situations.

# Coming Off-Line... Adventures in F2F!

After three years of sporadically playing online with Ralph and Nick for practice, Suzi and I found ourselves playing faceto-face at the recent ACBL District 13 Spring Regional in Middleton, WI. This was our first real venture back to the world of tournament bridge since the start of the pandemic.

Playing in the Open Pairs event on the first day of the tournament, we were well positioned to finish high in the event.

On Board 16, our last board of the day, I was on lead against a 5H contract with this hand:

**EW Vulnerable** West deals The auction went: S W Ν Е Stan Suzi **1**S 25\* **4**S 5D Ρ Ρ 5H Ρ Ρ Ρ Ρ \*2S showed the minors



I thought about the opening lead, but sadly, I did not think long enough. I chose to lead a small club.

With more thought, I would have realized that there are only thirteen spades in the deck!! Since E/W must hold nine spades for this auction and I held four spades, Suzi had to be VOID!! A spade lead followed by a diamond to my ace and a second spade ruff will defeat 5H.

The full layout was:

Defeating 5H would gain 3.5 matchpoints and give us the win. Alas, we finished in second place by 2.5 matchpoints. (Note: I do like to leave room for improvement...)

On to Day 2:

We learned from our mistakes and carried on to win the next day Open Pairs by two full boards!

AND: I redeemed myself from my sleepy last board play by scoring a top board on this hand:

Suzi opened 1D in second seat and I jumped to 3NT (13-15 HCP) on the four triple three South hand with no significant diamond support.

The opening lead was the S8.

I followed with the ten from dummy and East played the SQ. If spades are divided 4-3, I can win the king and drive out the DA for an easy nine tricks.

However, the lead of the S8 made it look likely that West was leading from a five card suit. In that case, it would be fatal to win the SK since when I drove out the DA, the opponents would be able to cash four rounds of spades.

I ducked the first trick and East continued with the S3.

I assumed that this was a standard return, and I suspected that West started with a five-card spade suit. I played small from my hand and West won the S9. If West cashes the SA, I can drive out the DA and take nine tricks.

Lucky for me, West decided to play East for S:KQ73 and continued with a low spade to unblock the suit!!

After winning the SK, I was able to drive out the DA and eventually scored ten tricks when East won the first round of diamonds and was squeezed in the minors.
